After a period of ten years, we present the second edition of the IRELAND, CATALOG OF PERFINS. The editor believes that it contains all designs shown to be from Ireland that have come to his attention. It is possible that he has failed to record one or two but there have been numerous cases where he felt the evidence was not strong enough to warrant listing.

Once again, we wish to thank the many contributors who supplied us with information. Among the most recent are gentlemen from Ireland and England.

Ten years ago, when we printed the first edition, we planned on a supply of catalogs that would last us ten years. This goal was proven to be correct as we have just run out of the first editions these past few months. This new edition contains, in addition to the first edition, the A&C material printed and made available in 1986, plus about an equal number of additions and corrections since that date.

You may be surprised to learn that Ireland is one of the most difficult countries to collect. The percentage of designs in the largest collections is surprisingly small. This actually adds to the enjoyment of the collecting.

Any study of the perfins of Ireland must include the stamps of both Eire and of Great Britain. Prior to 1922 the entire island used the regular postage stamps of Great Britain. With the formation of the republic in that year, stamps of Great Britain with overprints in Gaelic were used in Eire while the regular issues of Great Britain were used in Northern Ireland. Eire developed their own stamps the same year. From this date forward, perfins will be found on stamps of both countries depending upon where the mail is posted, in Eire, or in Northern Ireland.

No attempt has been made at this time to show the period of usage of any perfins illustrated herein. A record is being kept by the editor and perhaps at a future date such information will be made available. Many of the perfins herein are to be found also in the British catalogs of Tilles and Edwards.

Only perfins for which the editor has observed copies are shown in this catalog. Other designs have been indicated in lists prepared in the past. However, no design will be shown until an example can be photographed and supporting information is available to the editor. It is hoped that anyone having such material will submit it to the editor for inclusion in the catalog.

At the end of the catalog are two pages of suspected or previously reported designs. With the cooperation of readers, it is believed that most of these can be identified and added to the catalog. Fifteen listings have been removed since the previous listing and are now part of the catalog itself.

How to Use This Catalog

This catalog is designed as an album. All of the illustrations are full size, so you may choose to hinge a copy of the perfins over the illustration, or you may choose to insert additional pages on which to mount copies of the perfins illustrated.

Illustrations will always be found on the right hand pages. A row of blank spaces will be found on the left side of each page. These spaces are expected to be used for designs that may be added to the catalog or for illustration of special issues. There will also be several blank spaces at the end of each letter.

Left hand pages are divided into five columns:

Column one: Catalog numbers matching numbers of illustrations on the following page.

Column two: Letter description of the perfins.

Column three: Design designation, heights, number of holes in each letter, special information.

Column four: Country of usage: "I" for Eire, "B" for Great Britain.

Column five: Identification of user and Location of use. An asterisk (*) indicates positive identification.

All measurements are in millimeters. Height is measured center to center of holes. Width is measured from the outside of the holes. Distance between is measured between nearest holes.

Note that the presence or absence of a stop (period) in a pattern makes for a separate listing. This applies to both punctuation and to those stops which appear in C° and L°d. Where a serif appears in a pattern, it will be underscored.































